THIS BOOK QUESTIONS WHETHER INVESTMENT LAW INFLUENCES THE WIDER FIELD OF GENERAL INTERNATIONAL  
LAW AND MORE SPECIFICALLY WHETHER APPROACHES ADOPTED BY TRIBUNALS IN INVESTMENT ARBITRATIONS  
HAVE RADIATED OR SHOULD RADIATE INTO OTHER FIELDS OF INTERNATIONAL LAW

THE UNITED NATIONS HAS ESTABLISHED A RIGHT TO THE TRUTH TO BE ENJOYED BY VICTIMS OF GROSS  
VIOLATIONS OF HUMAN RIGHTS THE ORIGINS OF THE RIGHT STEM FROM THE NEED TO PROVIDE VICTIMS AND  
RELATIVES OF THE MISSING WITH A RIGHT TO KNOW WHAT HAPPENED IT ENCOMPASSES THE VERIFICATION  
AND FULL PUBLIC DISCLOSURE OF THE FACTS ASSOCIATED WITH THE CRIMES FROM WHICH THEY OR THEIR  
RELATIVES SUFFERED THE IMPORTANCE OF THE RIGHT TO THE TRUTH IS BASED ON THE BELIEF THAT BY  
DISCLOSING THE TRUTH THE SUFFERING OF VICTIMS IS ALLEVIATED THIS BOOK ANALYSES THE EMERGENCE OF  
THIS RIGHT AS A RESPONSE TO AN UNDERSTANDING OF THE NEEDS OF VICTIMS THROUGH TO ITS  
DEVELOPMENT AND APPLICATION IN TWO PARTICULAR LEGAL CONTEXTS INTERNATIONAL HUMAN RIGHTS LAW  
AND INTERNATIONAL CRIMINAL JUSTICE THE BOOK EXAMINES IN DETAIL THE APPLICATION OF THE RIGHT  
THROUGH THE CASE LAW AND JURISPRUDENCE OF INTERNATIONAL TRIBUNALS IN THE HUMAN RIGHTS AND ALSO  
THE CRIMINAL JUSTICE CONTEXT AS WELL AS LOOKING AT ITS PLACE IN TRANSITIONAL JUSTICE THE  
THEORETICAL FOUNDATIONS OF THE RIGHT TO THE TRUTH ARE CONSIDERED AS WELL AS THE VARIOUS  
OBJECTIVES APPROPRIATE FOR DIFFERENT TRUTH SEEKING MECHANISMS THE BOOK THEN GOES ON TO DISCUSS  
TO WHAT EXTENT IT CAN BE UNDERSTOOD CONSTRUCTED AND APPLIED AS A HARD LEGALLY ENFORCEABLE  
RIGHT WITH CORRELATING DUTIES ON VARIOUS PEOPLE AND INSTITUTIONS INCLUDING STATE AGENCIES  
PROSECUTORS AND JUDGES

THIS VOLUME PROVIDES AN INNOVATIVE AND ENGAGING WAY OF ASSESSING THE DEVELOPMENT OF  
INTERNATIONAL LAW SCHOLARSHIP AND PRACTICE TO DATE AND ITS POTENTIAL FUTURE DEVELOPMENT BY  
FOCUSING UPON THE LEADING WORKS OF THE DISCIPLINE INTERNATIONAL LAW HAS ESTABLISHED ITSELF AS AN  
IMPORTANT AREA OF ACADEMIC STUDY AND LEGAL PRACTICE GIVEN ITS ACADEMIC LEGAL AND EVERYDAY  
SIGNIFICANCE AND ITS PROLIFIC ROLE WITHIN LAW SCHOOL TEACHING AND RESEARCH IT IS IMPORTANT TO  
QUESTION AND ANALYSE THE DEVELOPMENT OF INTERNATIONAL LAW EXPLORING THE COMPLEX AND SHIFTING  
INTERPLAY BETWEEN LAW POLICY THEORY AND CULTURE AND THE ROLE OF INTERNATIONAL AND NATIONAL  
ACTORS WITHIN A DIVERSE AND DYNAMIC COMMUNITY OF NATIONS THIS COLLECTION PRESENTS  
CONTRIBUTIONS FROM LEADING SCHOLARS OF PUBLIC INTERNATIONAL LAW ACROSS THE GLOBE AND THE

WORKS CHOSEN BY THE EDITOR REPRESENT A DIVERSE RANGE OF SUBJECTS WITHIN THE BROADER DISCIPLINE. EACH CHAPTER ANALYSES THE IMPORTANCE AND LEGACY OF A SPECIFIC WORK WITH A VIEW TO REFLECTING UPON HOW THAT PUBLICATION HAS CONTRIBUTED TO SHAPING THE BROADER LITERATURE IN THE FIELD OF INTERNATIONAL LAW AND HOW IT MAY CONTINUE TO HAVE AN INFLUENCE ON BOTH SCHOLARSHIP AND PRACTICE IN THE FUTURE. TAKEN AS A WHOLE, THE CHAPTERS INCLUDED IN THIS COLLECTION PROVIDE AN ORIGINAL EXPLORATION OF A VARIETY OF IMPORTANT THEMES ABOUT HOW THE DISCIPLINE HAS EVOLVED OVER TIME. THE PROLOGUE AND EPILOGUE CRITICALLY ASSESS THE DEVELOPMENT OF INTERNATIONAL LAW IN LIGHT OF THE REFLECTIONS BY CONTRIBUTORS. IN THIS BOOK, KERRY O'HALLORAN ANALYSES A SUBJECT OF INTERNATIONAL INTEREST: RELIGION AND EXAMINES RELATED CONTEMPORARY ISSUES FROM A HUMAN RIGHTS PERSPECTIVE. THE BOOK TAKES THE VIEW THAT WHILE THE IMPACT OF ISLAMIC STATE VIOLENCE HAS DRAMATICALLY DEMONSTRATED THE DESTRUCTIVE POWER OF RELIGIOUS EXTREMISM FOR CONTEMPORARY WESTERN SOCIETIES, THERE ARE ALSO GOOD GROUNDS FOR THE LATTER TO EXAMINE THE EXTENT TO WHICH THEIR LAWS AND POLICIES, NATIONALLY AND INTERNATIONALLY, ARE CONTRIBUTING TO RELIGION'S CURRENTLY DESTABILIZING SOCIAL ROLE. IT MAKES THE CASE FOR A FULLER UNDERSTANDING OF THE ROLE OF RELIGION OR BELIEF AND ARGUES FOR A REBALANCING OF THE FUNCTIONAL RELATIONSHIP BETWEEN CHURCH AND STATE, BOTH NATIONALLY AND INTERNATIONALLY. BEGINNING WITH AN OVERVIEW OF RELIGION, INCLUDING AN EXAMINATION OF KEY CONCEPTS AND CONSTRUCTS, THE CHAPTERS GO ON TO OUTLINE THE INTERNATIONAL FRAMEWORK OF RELATED HUMAN RIGHTS PROVISIONS AND NOTE THE EXTENT OF THEIR RATIFICATION. IT PROCEEDS BY IDENTIFYING A SET OF THEMES, SUCH AS THE CONSTITUTIONAL POSITIONING OF RELIGION, LAW AND POLICY IN RELATION TO SECULARISM, FAITH SCHOOLS, EQUALITY LEGISLATION AND THE RELIGIOUS EXEMPTION AND THE TENSION BETWEEN FREE SPEECH AND RELIGION, AND UNDERTAKES A COMPARATIVE EVALUATION OF HOW THESE AND OTHER THEMES INDICATE SIGNIFICANT DIFFERENCES IN SIX LEADING COMMON LAW JURISDICTIONS, AS ILLUSTRATED BY THEIR ASSOCIATED LEGISLATION AND CASE LAW. IT THEN CONSIDERS WHY THIS SHOULD BE AND ASSESSES ANY IMPLICATIONS ARISING. THIS BOOK WILL BE OF GREAT INTEREST TO STUDENTS AND SCHOLARS IN THE FIELDS OF LAW, RELIGIOUS STUDIES, POLITICAL SCIENCE, HUMAN RIGHTS AND SOCIAL POLICY.

THE LAW OF THE SEA IMPOSES A LONG ESTABLISHED DUTY TO RESCUE PERSONS IN DISTRESS, WHICH CONNOTES ONE OF THE MOST IMPORTANT TOOLS IN SAFEGUARDING SAFETY OF LIFE AT SEA. OTHER RULES OF INTERNATIONAL LAW, NAMELY INTERNATIONAL HUMAN RIGHTS AND REFUGEE LAW, ALSO COME INTO PLAY IN DRAWING THE LEGAL PARAMETERS FOR THE CONDUCT OF RESCUE OPERATIONS AMID THE THOUSANDS OF PEOPLE UNDERTAKING PERILOUS SEA JOURNEYS IN SEARCH OF SAFETY. EUROPEAN LEGAL RESPONSES HAVE

PRIMARILY FOCUSED ON THE SECURITIZATION OF MIGRATION THIS BOOK EXPOSES THE HUMAN RIGHTS VIOLATIONS THAT MAY BE PERPETRATED AGAINST MIGRANTS ATTEMPTING TO CROSS THE MEDITERRANEAN AND STRONGLY ADVOCATES FOR THE DEVELOPMENT OF A FRAMEWORK FOR OPERATIONALIZING THE PROTECTION OF HUMAN RIGHTS AND LIFE AT SEA IT COMBINES THEORY AND PRACTICE IN WHICH PHILOSOPHICAL THEORIES OF RIGHTS ARE APPLIED TO CREATE A FRAMEWORK FOR LEGAL ANALYSIS AND THE DEVELOPMENT OF PRACTICAL LEGAL STANDARDS THE STUDY PRESENTS AN INNOVATIVE EVALUATION OF SELECTED JUDGMENTS OF THE EUROPEAN COURT OF HUMAN RIGHTS AND OTHER INTERNATIONAL HUMAN RIGHTS BODIES PERTAINING TO COMPLEX QUESTIONS OF EXTRATERRITORIAL JURISDICTION AND A STATE'S HUMAN RIGHTS OBLIGATIONS TOWARDS PERSONS IN DISTRESS AT SEA THE BOOK WILL BE OF INTEREST TO ALL THOSE ENGAGING WITH MIGRATION AND SECURITY STUDIES INTERNATIONAL HUMAN RIGHTS SCHOLARSHIP INTERNATIONAL LAW OF THE SEA REFUGEE AND MIGRATION LAW AND LEGAL PHILOSOPHY WHETHER GENERALIST OR SPECIALIST

THIS VOLUME OF ESSAYS EXAMINES THE DEVELOPMENT OF POLITICAL AND LEGAL THINKING REGARDING THE USE OF FORCE IN INTERNATIONAL RELATIONS IT PROVIDES AN ANALYSIS OF THE RULES ON THE USE OF FORCE IN THE POLITICAL NORMATIVE AND FACTUAL CONTEXTS WITHIN WHICH THEY APPLY AND ASSESSES THEIR CONTENT AND RELEVANCE IN THE LIGHT OF NEW CHALLENGES SUCH AS TERRORISM WEAPONS OF MASS DESTRUCTION AND CYBER ATTACKS THE VOLUME BEGINS WITH AN OVERVIEW OF THE ANCIENT AND MEDIEVAL CONCEPTS OF WAR AND THE USE OF FORCE AND THEN CONCENTRATES ON THE CONTEMPORARY LEGAL FRAMEWORK REGULATING THE USE OF FORCE AS MOULDED BY THE UNITED NATIONS CHARTER AND STATE PRACTICE IN THIS REGARD IT DISCUSSES SPECIFIC ISSUES SUCH AS THE USE OF FORCE BY WAY OF SELF DEFENCE ARMED REPRISALS FORCIBLE REACTIONS TO TERRORISM THE USE OF FORCE IN THE CYBERSPACE HUMANITARIAN INTERVENTION AND THE RESPONSIBILITY TO PROTECT THIS COLLECTION OF PREVIOUSLY PUBLISHED CLASSIC RESEARCH ARTICLES IS OF INTEREST TO SCHOLARS AND STUDENTS OF INTERNATIONAL LAW AND INTERNATIONAL RELATIONS AS WELL AS PRACTITIONERS IN INTERNATIONAL LAW

INTERNATIONAL LAW IS BOTH AN INTRODUCTION TO THE SUBJECT AND A CRITICAL CONSIDERATION OF ITS CENTRAL THEMES AND DEBATES THE OPENING CHAPTERS OF THE BOOK EXPLAIN HOW INTERNATIONAL LAW UNDERPINS THE INTERNATIONAL POLITICAL AND ECONOMIC SYSTEM BY ESTABLISHING THE BASIC PRINCIPLE OF THE INDEPENDENCE OF STATES AND THEIR RIGHT TO CHOOSE THEIR OWN POLITICAL ECONOMIC AND CULTURAL SYSTEMS SUBSEQUENT CHAPTERS THEN FOCUS ON CONSIDERATIONS THAT LIMIT NATIONAL FREEDOM OF CHOICE

E G HUMAN RIGHTS THE INTERCONNECTED GLOBAL ECONOMY THE ENVIRONMENT THROUGH THE ORGANIZING CONCEPTS OF TERRITORY SOVEREIGNTY AND JURISDICTION THE BOOK SHOWS HOW INTERNATIONAL LAW SEEKS TO ACHIEVE AN ESTABLISHED SET OF PRINCIPLES ACCORDING TO WHICH THE POWER TO MAKE AND ENFORCE POLICIES IS DISTRIBUTED AMONG STATES

THE HUMAN RIGHTS OF COMMUNITIES IN MANY RESOURCE RICH WEAK GOVERNANCE STATES ARE ADVERSELY AFFECTED NOT ONLY BY THE ACTS OF STATES AND THEIR AGENTS BUT ALSO BY POWERFUL NON STATE ACTORS CONTEMPORARY PHENOMENA SUCH AS GLOBALISATION PRIVATISATION AND THE PROLIFERATION OF INTERNAL ARMED CONFLICT HAVE ALL CONTRIBUTED TO THE INCREASING PUBLIC INFLUENCE OF THESE ENTITIES AND THE CORRELATIVE DECLINE IN STATE POWER THIS BOOK RESPONDS TO THE PERSISTENT CHALLENGES STEMMING FROM NON STATE ACTORS LINKED TO EXTRACTIVE INDUSTRIES IN LIGHT OF THE INTERSECTING ROLES OF MULTINATIONAL ENTERPRISES AND NON STATE ARMED GROUPS IN THIS CONTEXT THESE ACTORS ARE ADOPTED AS THE PRIMARY ANALYTICAL VEHICLES THE OPERATIONS OF THESE ENTITIES HIGHLIGHT THE PRACTICAL FLAWS OF EXISTING ACCOUNTABILITY REGIMES AND PERMIT AN EXPLORATION OF THE THEORETICAL CHALLENGES THAT PRECLUDE THEIR DIRECT LEGAL REGULATION AT THE INTERNATIONAL LEVEL DRAWING INSIGHTS FROM DISCURSIVE DEMOCRACY COMPLIANCE THEORIES AND THE PURE THEORY OF LAW THE BOOK ESTABLISHES A CONCEPTUAL FOUNDATION FOR THE CREATION OF BINDING INTERNATIONAL OBLIGATIONS ADDRESSING NON STATE ACTORS RESPONDING TO THE RECENT CALLS FOR A BINDING BUSINESS AND HUMAN RIGHTS TREATY AT THE UN HUMAN RIGHTS COUNCIL AND THE GROWING INFLUENCE OF ARMED NON STATE ACTORS THE BOOK MAKES A TIMELY CONTRIBUTION TO DEBATES SURROUNDING THE DIRECTION OF FUTURE DEVELOPMENTS IN THE FIELD OF INTERNATIONAL HUMAN RIGHTS LAW
